

Regarding Incident on October 31, 2024

I, the living man **Kyllon Anthony**, an American State National, do solemnly affirm the following facts to be true, correct, and complete to the best of my firsthand knowledge:

STATEMENT OF FACTS:

1. On the date of October 31, 2024, I was traveling as a **passenger** in a private conveyance not engaged in any commercial activity.
2. I was unlawfully removed from the vehicle by Officer **Timothy Quatro**, acting under Monroe County Sheriff's Office.
3. I was not the driver, was not under suspicion of a crime, and no warrant was presented.

Regarding Incident on May 4, 2025 – Personal Unlawful Detainment

Regarding Incident on May 4, 2025 – Unlawful Seizure of Trust Property

I, the living man **Kyllon Anthony of the House Robinson**, acting as Trustee of *The Eternal RobinsonVillage Bloodline Legacy Trust*, do solemnly affirm the following testimony as lawful truth:

STATEMENT OF FACTS:

1. On May 4, 2025, the private trust conveyance — a **Honda automobile** held under *The Eternal RobinsonVillage Bloodline Legacy Trust* — was unlawfully seized by Officer **D. Minardo** of the Rochester Police Department.
2. Said conveyance was not engaged in commerce, was not registered with the state, and was clearly identified as **private trust property** via lawful documents served at the time of seizure.
3. The conveyance displayed **lawful identification tags** and all necessary paperwork was available, including:
 - Trust Abstract
 - Affidavit of Ownership
 - UCC-1 Financing Statement
 - Trustee ID
 - Affidavit of Lawful Transportation Rights

4. These instruments were ignored, and the property was taken to an impound facility without lawful justification, warrant, or contractual authority.
5. This seizure constitutes **theft, unlawful conversion of trust property, impersonation of jurisdiction, and commercial interference.**

- The violations committed by the named parties (RPD, Monroe County Sheriff's Office, etc.) are now subject to lawful claim and tort remedy.

- \$50,000.00 – Interference with trust operation, movement, and spiritual responsibility
- \$25,000.00 – Emotional distress and harm caused by false imprisonment
- \$1,000.00/day from May 4, 2025 – Ongoing theft and conversion of private trust property (Honda) (**daily accruing**)


